(a) To change the name of the Corporation to:

COMMUNITY LIVING DURHAM NORTH

The Corporation is not insolvent within the meaning of subsection 19(4) of Ontario Regulation 181.

- (b) To delete numbers 1 to 7 inclusive from the objects from the original Letters Patent which reads:
 - 1. TO assist the retarded in realizing their individual contribution to the community;
 - 2. TO encourage scientific research and study into the reasons for mental retardation with a view to preventing it; and seek the co-operation of all the authorities toward this end;
 - 3. TO develop a better understanding of the problems of mental retardation by the general public;
 - 4. TO encourage training and education of personnel in the field of mental retardation;
 - 5. TO co-operate with other provincial, national and international organizations promoting the education and welfare of the mentally retarded;
 - 6. TO unite the efforts and all parents and friends interested in any one residential or industrial centre; and
 - 7. Subject to the Mortmain and Charitable Uses Act and The Charitable Gifts Act, to solicit and receive funds for the accomplishment of the above objects.
- (c) To change the objects of the Corporation by adding:

- 1. To further the social well-being of people who have intellectual disabilities by ensuring that they have opportunities for optimal personal development and the necessary support to realize personal aspirations.
- 2. To encourage respect of people with intellectual disabilities by educating and encouraging the community and furthering the development of the community's capacity to include, support and accommodate people who have intellectual disabilities.
- 3. To facilitate the participating of people with intellectual disabilities of all ages in the life of the community and its economy by offering supports and services tailored to the unique needs, gifts and aspirations of each individual in receipt of such support.
- 4. To unite the efforts of all self-advocates and their family members, friends and other persons interested in the welfare of people with intellectual disabilities in our community, and to co-operate with such organizations, agencies, government departments, and other groups whose purposes are consistent with these objectives.
- 5. To support and further the training and education of those working with and on behalf of persons with intellectual disabilities.
- (d) To add the following special provisions:
 - 1. Subject to applicable legislation, to solicit, receive, acquire and hold gifts, donations, legacies and devices, to collect fees, and to enter into contractual arrangements with government for the accomplishment of the foregoing Objects.
 - 2. To invest the moneys of the Corporation not immediately required for its Objects in any securities in which, under the Trustees Act, trustees may invest funds.
 - 3. To establish, maintain and operate facilities for the provision of support services to persons with intellectual disabilities, consistent with the Objects of the Corporation.
